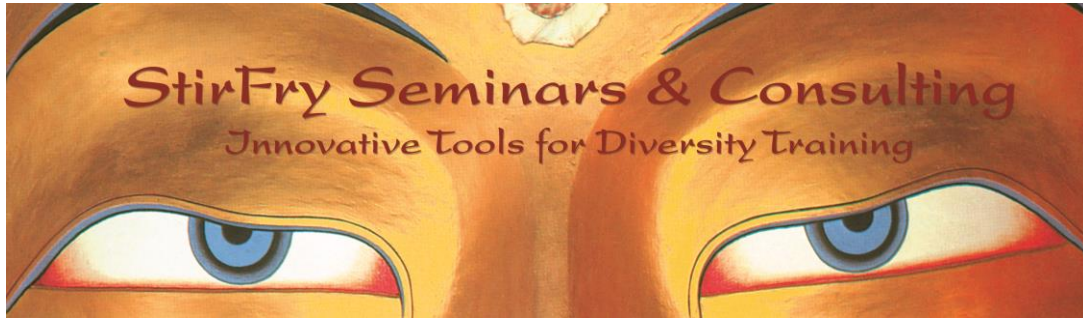


Mindful Facilitation Internship Training Program
